### **Request Initiated by PE.**

- 1 On the Entity panel in the side menu bar, there will be a "PE-TM Chain" option.
- The option of initiating a new request will be there.
- 3 The Entity has to enter the respective Telemarketer ID. Then click on view details, and the name of the TM will appear.

Upload the document if required.

Click on "Submit Button".

The request will be submitted to TM for acceptance & defining its role as TM aggregator or TM Delivery.







#### **Status View at Entity Panel**

- Submitted Request will be visible under the Pending PE-TM Chain section with the status "Pending at TM.
